Required Identity Documents

1. Data Subject

- A copy of the identification card or valid official document with photograph of the cardholder issued by the government, such as a driver's license (Thai citizen)
- A copy of the Passport (Foreigner)

2. Data Subject's Representative

- Power of Attorney
- A copy of the Identification card of Data Subject and Data Subject's Representative or valid official document with photograph of the cardholder issued by the government, such as a driver's license (Thai citizen)
- A copy of the Passport of Data Subject and Data Subject's Representative (Foreigner)

Remarks

For any of your Sensitive Personal Data which have been contained in identity documents, you may conceal the sensitive personal data, such as religion, race, or blood type. The Company shall maintain the right to conceal and perceive that the sensitive personal data has not been obtained if you do not proceed before submission.

The Company may request more information or additional documents from the Requester. If the request is not explicit, unclear or insufficient to verify that the Requester is eligible to submit the request, the Company has a right to reject your request.

Company Declaration

The Company may reject your request in the following cases:

- (1) Requester fails to verify identity or eligibility
- (2) Request is invalid. For example, you are not entitled to make a request, or your personal data are not found in Company storage, etc.
- (3) Request is repetitive without reasonable causes.
- (4) Personal Data Processing of personal data is needed for freedom of expression; or for historical documents or annals for public interest or research or statistical purposes under the appropriate protection measures or necessary for Company's operations or performance of granted authority by laws or any processing of the sensitive personal data which is still needed to achieve following the purposes of preventive medicine, occupational medicine, public interest in public health under the Articles 25 (5) (a) and (b) of the Personal Data Protection Act.
- (5) Personal Data Processing is necessary for establishment, compliance or exercise of legal claims, or defense of legal claims
- (6) Proceeding with the request negatively affects freedom of others
- (7) Personal Data Processing is obliged by laws

- (8) Personal Data Processing is necessary for the Company's performance of a task carried out in the public interest or exercising vested by official authority or laws.
- (9) Personal Data Processing is necessary for contractual obligation between the Data Subject and the Company.
- (10) Personal Data Processing is necessary for legitimate interests.

The Company will process your request free of charge. However, the Company may charge a reasonable fee if your request is deemed unreasonable or repetitive.

The Company will consider your request and notify you of the outcome of consideration within 30 days from the date of receiving your request.
